**Show Hall.** Florence City-County Civic Center, One Civic Center Plaza, 3300 West Radio Drive, Florence, SC 29501-7802, (843)679-9417, [www.florenceciviccenter.com](http://www.florenceciviccenter.com). This is a non-smoking show hall and is air-conditioned and handicapped accessible. This year's show will be held in the Civic Center's Arena. **It is the policy of the Florence City-County Civic Center that no outside food or drink be brought into the facility.**

**Show Hotels.** Ramada Inn, 2038 W. Lucas St., Florence, SC 843-669-4241. Quality Inn, 150 Dunbarton Dr., Florence, SC, 843-664-2400. Driving directions will be sent with confirmations.

**Benching.** Check-in on Saturday will be from 8:00 am until 9:30 am. Judging will begin at 10:00 am on Saturday and 9:00 am on Sunday. Advertised show hours are 10:00 am until 5:00 pm Saturday, 10:00 am until 4:00 pm Sunday. No cats are permitted to leave the show hall before the advertised show hours except by permission of the Show Manager. Cages, provided by Mid-Atlantic Show Service, are approximately 22"x22"x22".

**Entry Information.** All fees and benching requests must accompany entries. No phone entries. Faxed and e-mail entries will be accepted but should be confirmed with a phone call or e-mail. Exhibitors entering on-line will receive an e-mail confirmation with show announcement and driving directions. Mailed and faxed entries will receive an e-mail confirmation if the e-mail address is noted on the entry. **Faxed and e-mail entries must be followed by a check within 10 days but no later than check-in. Any fees not received within 4 days of the end of the show (by Oct. 4), will be assessed a \$30 late payment fee.** Make checks payable to **Coastal Paws Cat Club**. Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. On-line entries may be submitted from our web site at <http://www.coastalpaws.com>. If questions arise concerning your entry, entry clerk will e-mail exhibitor if e-mail address is listed on the entry form, otherwise, entry clerk will call **collect**. One benching request per exhibitor will be honored, if possible. If an agent is designated, the agent will be considered your benching request.

**Household Pets.** Household Pets will be judged in all rings. Kittens must be over 4 months old and all pets 8 months old or older must be spayed or neutered. NO declawed cats or kittens may be shown. Cats should be transported to the show in a carrier.

**Supplies.** Litter will be provided. Please bring cage curtains, fabric or towels for your benching cage. Food bowls, water bowls and litter pans will not be furnished.

**Health & Sales.** This is a non-vetted show. All cats, kittens and household pets are expected to be free of fleas, fungus, ear mites and all contagious diseases. All entries should be inoculated against Feline Distemper, Feline Rhinotracheitis, Calici viruses, Rabies and be tested negative for Feline Leukemia before entry to the show hall. All claws must be clipped prior to benching. Declawed cats, kittens and household pets are not eligible for entry. No kittens under four months of age will be permitted in the show hall. Exhibitors in violation will be asked to leave.

**Liability.** No watchman will be provided during non-show hours. Cats cannot be left in the show hall overnight. Neither Coastal Paws Cat Club, their members nor Florence City-County Civic Center are liable for any loss, damage or injury.

**General.** CFA Show rules will be strictly enforced. A copy of the current show rules may be obtained for \$5 from CFA, PO Box 1005, Manasquan, NJ 08736. All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional Awards. Registration numbers must be printed or written in ink in the catalog. It is the exhibitor's responsibility to check entry confirmation and notify entry clerk of any errors.

**Airports.** Florence Regional Airport (FLO). The club is unable to provide transportation to or from the airport. Myrtle Beach International (MYR), 68 miles. Columbia Metropolitan (CAE), 90 miles.

#### **Directions to the Civic Center**

I-95 traveling North or South Exit 160A. Go to the first traffic light and turn right. Florence Civic Center will be found directly ahead of you.

I-20 traveling East. Follow I-20 until it becomes I-20 Spur. Go to the first traffic light and turn right. Florence Civic Center will be found directly ahead of you.
